# BAKHTUNNESSA CHOWDHURY DIABETES CENTRE UPGRADATION, KULAURA, MOULVIBAZAR

In the heart of Kulaura upazila, the Bakhtunnessa Chowdhury Diabetes Centre began its journey in 2000. Established by East Coast Group, this centre, named after Bakhtunnessa Chowdhury, the revered mother of our Chairman, Mr. Azam J Chowdhury, emerged as a beacon of compassion.



Alongside our honorable Chairman, the inauguration ceremony of the newly upgraded Bakhtunnessa Chowdhury Diabetes Centre was graced by the presence of key figures from East Coast Group, including Mr. Tanjil Chowdhury, Managing Director; Ms. Dilruba Chowdhury, Director; Major General Nayeem Ashfaque Chowdhury (Retd), Executive Director; Col Liaquat Ali Khan (Retd), Head of CSR; and Mr. Md. Shipar Uddin Ahmed, the honorable Mayor of Kulaura City Corporation.

The mission was simple yet profound – to provide free medical treatment to impoverished diabetic patients. Every year, it has now become the lifeline for nearly **9000 patients** who found solace within its walls, receiving not just treatment but diagnostic facilities and subsidized medicine.



#### The Vision for Modern Healthcare

As the sun set over Marina Square, Dakkhin Bazar, Kulaura- the need for modern healthcare became more apparent, this being the only diabetes center available in the entire Kulaura upazila. With minimal facilities and only two dedicated doctors, the challenges were evident.

Our honorable Chairman, Mr. Azam J Chowdhury, during his visit on 14 February 2022, witnessed the need for an upgrade from a specialized Diabetic Centre to a multipurpose medical treatment hub. Motivated by the desire to enhance medical facilities for diverse areas, the Chairman envisioned a modern haven for health.

The upgrade, completed on 16 September 2023 and inaugurated by the honorable Chairman, unveiled a state-of-the-art Medical Centre. The centre now has specialists from various sectors, including medical specialists, gynecologists, child specialists, ophthalmologists, orthopedists, and many more. This has increased the number of doctors from only two to more than eight.

#### Addressing Local Healthcare Needs

Bakhtunnessa Chowdhury Diabetes Centre's upgrade was not just about medical progress; it was a response to the intricate healthcare needs of the local community. Complications related to various health challenges and diseases, once undiagnosed locally, found attention and care.


The upgraded centre, now a symbol of hope, is equipped with state-of-the-art technology, including the FUJIFILM FDR SMART f 500 Ma X-Ray, 4D Color Doppler Ultrasound Machine, Fully Automated Biochemistry Analyzer, Fully Automated Immunochemistry Analyzer, Hematology Analyzer, ECG Machine, and ESR Machine, poised to address complexities.



As the aspirations for quality education soared, the institution faced the challenge of space constraints. Responding with characteristic decisiveness, our Chairman assisted in the acquisition of an additional 45 Decimal land adjacent to the school in February 2022, ensuring local children no longer needed to travel long distances for quality education.



Subsequently, on 14 February 2022, to further enhance the college's establishment, our respected Chairman personally selected 11 skilled teachers across various subjects through a comprehensive assessment. This hands-on approach was the first step for shaping the dream college for the locality.

#### Building Dreams: The Inauguration of the College Construction

In 1965, this mosque was initially established for the use of officers and employees of the then East Pakistan's Forest Industries Development Corporation. In 2003, we acquired this area from the Bangladesh Forest Industries Development Corporation for the employees of Nordic Wood Limited, a subsidiary of East Coast Group. However, over time, the condition of the mosque deteriorated, leading to its partial usability. Eventually, in 2015, due to safety concerns, the mosque was demolished, and an alternative prayer area was established.

### MYC CHARITABLE FOUNDATION ZAKAT DISTRIBUTION THROUGH DIGITAL BANKING 2024


