EC Bulk Carriers Limited

By the Grace of Almighty Allah, MJL Bangladesh PLC, a subsidiary of East Coast Group, achieved a significant milestone in it's maritime journey with the signing of a Memorandum of Agreement (MOA) with Bigal Shipping Corporation of Liberia on 31 December, 2024. The agreement was for the purchase of an Aframax Tanker (DWT 115,690 MT), built in 2012 at a South Korean shippard.

On 09 April, 2025, the vessel was officially taken over in Singapore and re-named OMERA GALAXY. This tanker now holds the distinction of being the largest vessel sailing under the Bangladesh flag. More than just a fleet addition, this acquisition represents a strategic investment in the future of sustainable and responsible shipping, as the vessel is equipped with advanced technologies in line with the latest IMO regulations, supporting our long-term goals of decarbonization, fuel efficiency, and environmental responsibility.

Continuing our commitment to future-ready maritime operations, another major milestone was reached on 22 April 2025, when steel cutting commenced for a brand-new LR2 Tanker (DWT 115,690 MT) at Daehan Shipbuilding Co. Ltd., South Korea. This project marks a new era for the Bangladeshi shipping sector—constructing a vessel at an internationally renowned shippard



that focuses on energy efficiency, greener operations, and carbon footprint reduction. The vessel is being built to align with evolving IMO environmental standards and the broader energy transition goals shaping the global shipping industry.


These milestones reaffirm East Coast Group's vision to lead in maritime excellence while championing sustainable growth and innovation.

VLGC STS Operation: A milestone by East Coast Shipping Lines Limited (ECSLL) for LPG Supply to Bangladesh.

East Coast Shipping Lines Limited (ECSLL) has played a pivotal role in strengthening Bangladesh's LPG supply chain. In collaboration with Omera Petroleum Limited and MJL (S) Pte Ltd, ECSLL has successfully executed Ship-to-Ship (STS) operations from Very Large Gas Carriers (VLGCs) by pressurized LPG vessels.



Acting as STS coordinator and local agents, ECSLL manages and coordinates the entire STS process—demonstrating innovation, operational excellence, and a strong commitment to supply chain efficiency. These advanced operations now contribute to meeting up to 40% of the country's LPG demand, highlighting ECSLL's vital role in

energy logistics.

Since 2023, ECSLL is facilitating 12 nos. VLGC STS Operations every year with a combined handling capacity of about 513,759 metric tons LPG per year marking a significant contribution to national energy infrastructure.







Zakat Distribution through Electronic Fund Transfer
